Assets - the Council has insured the following assets: -

Playing field with Pavilion - insured value £300,000 with £1,953.33 contents cover
Two motor mowers and one lawn mower - insured value £1,449.67
War Memorial - insured value £6,887.46
Street furniture – insured value £1,458.79 (3 x wooden benches - 1 x metal bench)
Playground equipment – insured value £46,695.48
Business equipment – insured value £5,000

Total insured value of assets is £361,491.40. In reality, these are community assets with a nominal value of £1.00.

NB. The insurance will be updated to reflect recent changes in assets.

Borrowings - the Council has no borrowings.

Leases - the Council has no lease arrangements.

Allotment tenancies - the Council has a total of 26 full plots and 10 half plots which are currently occupied at a rate of £24 a year for a full plot and £12 a year for a half plot. There is one full plot that is being maintained as an allotment community space.

Section 137 Payments

Section 137 of the Local Government Act 1972 enables Parish Councils to spend up to the product of £7.42 per elector for the benefit of people in the area on activities or projects not specifically authorised by other powers.
